#### **OUR MAIN OBJECTIVES**

### 1 CATEGORY 0S24 - (GREEN AND STREET FURNITURE):

We envisage making this mandatory for contracts falling into this specific category and require trained and specialized manpower to carry out jobs related to greenery, outdoor furniture and specific vehicles appropriate for this sector.

#### 2 PROFESSIONALISM OF THE COMPANY

We envisage making the following certifications mandatory for participating in tenders:

- UNI EN ISO 14001:2015 is the certificate of the environmental management system;
- ISO 45001:2018 is the certificate of the health and safety system in the workplace;
- SA8000:2014. is the certificate that identifies an international standard aimed at certifying some aspects of management relating to corporate social responsibility;

#### 3 CAM (MINIMUM ENVIRONMENTAL CRITERIA):

We envisage a full implementation of CAM (Minimum Environmental Criteria) in the tenders for the management of public parks and products supply for the care of the green, established in 2013 and made mandatory in 2016 with the new code of public tenders, which were updated in 2020;

#### 4 ENSURING COMPETITION PROTECTION:

We envisage a full implementation of the criterion about the most economically advantageous offer by the contracting authorities, as required by the new procurement code, in order to ensure the selection of the best quality / price ratio, which enhances the qualitative elements of the offer and identifies the criteria to guarantee an effective comparison on the technical profiles. To this end, the contracting authority will establish a ceiling equivalent to 30 percent.



#### **OUR PRIORITIES**

- WORK FORCE A skilled workforce is the lifeblood of our businesses. AIDA works at European, national and regional levels to ensure an adequate and legal workforce for GREEN CARE companies so that they can deliver quality work and growth in accordance with what the market requires. We also facilitate training efforts to shape the skilled workers and leaders essential to the Green Care industry for its growth.
- WATER The plants we plant need water to grow. AIDA supports a strong state and regional water supply policy to enable sensible protection, development and access, both in the short and the long term.
- WEEDING The health of our plants is the health of our businesses. AIDA supports research to experiment new non-chemical solutions for weeding that are not harmful to health for our workers, to the people who use them or to the environment, while guaranteeing continuous access to the market for responsible green managers.
- REGULATIONS We are business people. AIDA engages state and regional decision-makers on matters of concern for employers and the business community, including proposed or required legislation, to minimize regulatory expenses and enable profitability.
- COSTS Taking care of urban and suburban greenery means incurring into costs. AIDA encourages the development of purchasing consortia to try to contain the rising prices of products. We look for new national and regional systems to fight the increases in gas, electricity and petrol.


